She worked as a special education teacher and a regular education classroom teacher prior to her career as an elementary school counselor in Richland School District One. She has presented at local and state conventions on the subject of Play Therapy and "Sandplay" with a child-centered approach.



Overview: This training workshop will introduce participants to a brief history of Play Therapy, and the basic Play Therapy theories and techniques used by professionals in the field. The presenter will provide information about materials needed for Play Therapy and the applications in clinics and practice practices.

Learning Objectives: Participants will 1) become familiar with the historical rationale for the use of play therapy; 2) identify the theories of play therapy; 3) review techniques used in Child Centered Play Therapy; 4) explore play therapy materials and sources to obtain the items; and 5) identify application methods in a clinical and a private practice setting.

Significance for the counselor, therapist or social worker: Play Therapy is an important technique in child therapy. Because there are only a few courses offered in the local colleges and universities, much of the education about Play Therapy is provided during workshops and conferences.
